# B-1-c High School Course Proposal

Jennifer Wene, Director of Academic Achievement and Professional Development, presented recommended revisions to the high school curricula for the 2016-2017 school year, to include a new course, as indicated in Enclosure B-1-c.

#### B-1-d Changing Grading Practices

Dr. Neil Gupta, Director of Secondary Education and Mr. Patrick Callaghan, Director of Elementary Education led the Board of Education in a discussion about changing grading practices in Worthington Schools.

## B-1-e Board/Committee Reports, Announcements and Updates

Mr. Wilson, who attended 11 sessions at the National School Board Association's National Meeting, stated that the ongoing theme in the sessions was that we are no longer in a knowledge based economy, but an innovative economy, so schools should be turning out innovators. Mr. Wilson explained that we already have knowledge through technology, but students must have the skills to use this technology so they can develop collaborative creative problem solving skills, which is what is needed to work in an innovative economy. Mr. Wilson added that the sessions stressed that schools should not reward individual achievement because innovation is a team-based exercise. Great teachers form teams of learners and engage in team-building as innovators must be willing to try something new, fail and take chances.

Mr. Wilson, who saw the film Most Likely to Succeed, which shows how schools can prepare students for the 21<sup>st</sup> century, said that the Worthington Educational Foundation is giving a partial grant so that the community can also see this film. Mr. Wilson added that over 200 school districts and corporations are also devoting a day to "play" to get students and employees to be passionate in what they are doing. Under the supervision of teachers and coaches, students can pursue something they are passionate about, such as learning how to cook or play an instrument.

Finally, Mr. Wilson said that most of the country's top school districts are spending about 6-10 percent of their budgets on Research and Development. These innovation funds allow teachers to create new ways of doing things that have never been done before, as we have never lived before in an innovative economy.

Mr. Shim stated that he and Mrs. Best had their Finance Committee meeting with Treasurer Jeff McCuen to discuss the Five-Year Forecast. Mr. Shim thanked Mr. McCuen for explaining the forecast that will be presented to the board at the May 9th board meeting.
