INFORMATION AND PROPOSALS

B-1-a Visitor Comments

August 24, 2020 7:30 p.m.

Mr. Chris Scott of 6085 Olentangy River Road said that he did a public records request and is concerned there is infighting amongst the Board members. He also feels that there is a lack of transparency in how decisions are made. He thinks the focus should be on educating the children.

Ms. Deborah Abbott of 2099 Millrow Loop said that she homeschooled her kids and that they transitioned into Worthington Schools successfully in 2013. Her oldest was in color guard at Kilbourne and her younger son also wanted to do so but the season shut down and now he is struggling with remote learning.

Mr. Scott Fair of 217 Greenbrier Court told the Board he is the father of two sons and he wants his kids to go back to school. He thinks another survey should be done to see what the community wants the District to do about opening. He thinks families need a break to go to school and for kids to be kids.

Mr. Geoff Hatcher of 1013 Clubview Blvd S said he has emailed the Board some additional data and they could refer to those emails for more information. He is concerned by the data inconsistencies between the Ohio Board of Health and Columbus Public Health on Covid-19 numbers.

Ms. Sheri Jones of 7639 Ashworth Place told the Board that the fully remote plan fails to give students equal access to education. She does not think health officials have provided a clear criterion for when they will revise their recommendations for in-person learning.

Mr. Chris Demko of 8108 Storrow Drive would like to see students back in school. He also feels that schools going peanut free is catering to the minority. He said only about 2 percent of people are allergic to peanuts. He thinks there should be reasonable options for the District.

Mr. Chris Straley of 1510 Oakbourne Drive said that he is an educator and fears that children who are on IEPs needs are not being met with remote learning. He said his student is on an IEP and struggles to focus during online learning. He feels there is a lack of a plan around children with special needs.
