REQUESTS / QUESTIONS / CONCERNS FROM THE BOARD

Mr. Wilson and Mrs. Best disagreed with the public speaker comments. Mr. Wilson said that he believes that the administration and the board handled the task force exactly as it should and that there was nothing planned in advance. Mr. Wilson explained that the task force was not set up to get a certain grade configuration and that the board had no prior discussions about what it was going to do – and as far as he knew – the administration had no plans either. Mr. Wilson added that had the board of education come up with the position that the principals and administrators preferred the option of K-5, then it would have seemed like the board was "rubber stamping" as it was for the task force to come up with this option. Mr. Wilson stated that the superintendent and the administration handled it as it should have been; adding that this task force is not a rubber stamp and it came up with its own recommendations.

Mrs. Best explained that she has been on this board of education a long time and the district has never taken a stand on K-5 or K-6 as there are benefits with either choice. Mrs. Best explained it was not like the board knew all along which option was better. Mrs. Best said that the task force was getting to a time of looking at the two different options and trying to make a decision, which has been difficult. However, Mrs. Best added it's not like the board has known all along which way was better, it's just that she thinks moving Evening Street sixth grade to Kilbourne Middle School last year has definitely helped with the decision this year.
