### B-1-b Board/Committee Reports, Announcements and Updates

Mr. Schare thanked Dr. Bowers for providing the board a list of district events for August and September. Mr. Schare said that he attended New Teacher Orientation which marks the beginning of a teacher's journey in Worthington Schools. Mr. Schare added that the first days of a job are important and the feeling at New Teacher Orientation is so glad you took the job, coupled with expectations, and coupled with a superb mentoring program that will pay dividends for a generation of children.

Mr. Schare also gave a shout out to Worthington Hills Principal Allie Seiling for giving him a guided tour of the modular building that will house two fourth grade classrooms, adding the classroom space is enormous and positioned just outside the doors leading to the school's other fourth grade classrooms and bathrooms. Mr. Schare then thanked the Facilities Team for getting this set up as quickly as they did.

Mr. Schare said he attended a WKHS pep rally yesterday and was amazed to learn that the Worthington Kilbourne Marching Band has recruited 150 students.

With regards to education legislation, Mr. Schare explained that not much has been introduced. Mr. Schare said that SB149 seeks to require a school district to - upon notification by the Board of Elections that they intend to use the building as a polling place - keep the building closed to students for the day. Mr. Schare added that this is not optional but a mandate and that there would be no differentiation between a presidential election day or a city council primary day, and the school district would get only an eight month notice, which is not enough time to change the school calendar.

Mr. Schare stated that SB172 seeks to codify the process of applying for free and reduced price lunch status by changing the responsibility from the parent to the school district, assuming the school district finds out that a parent may be eligible. Mr. Schare added that SB172 also makes illegal the practice of discarding food that has been served because of a student's inability to pay for it, requires the principal or counselor to contact the parent and offer assistance with the free lunch application, for the principal to determine if there are other issues within the household that has caused the child to have insufficient funds, and finally to offer any other assistance that is appropriate.

Mrs. Keegan stated that it's possible but doubts no one does New Teacher Orientation better than Worthington Schools, adding that our Administration does a great job putting it on as you can see from attendee tweets of feeling so welcomed by the district.

Mrs. Keegan said she is excited to go to Convocation tomorrow and knows that a lot of up front work came from Communications, the Superintendent and Administrators and thanked everyone in advance for all their hard work. Mrs. Keegan also stated that she had a chance to see new Athletic Director Jennifer Goebbel in action at TWHS and it was fun to see as Jennifer has so much energy. Mrs. Keegan said there is a feeling that we're excited about our school district in this room and in all of our school buildings, adding that it's just a great feeling and thanked everyone who makes that happen.

Mrs. Best also said that New Teacher Orientation was an amazing and great day, adding she loved seeing all the tweets afterwards of everyone having so much fun. Mrs. Best said the board got a thank you note from Jennifer Wene for her retirement gift and asked any board members who would like to attend the upcoming Pepple and Waggoner School Law Update Seminar to let Mr. McCuen know.
