B-1-c Board/Committee Reports, Announcements and Updates

Mr. Wilson said he followed up on the board's policy discussion and contacted two centers for defense funds – the transgender legal defense and education fund and the national center for transgender equality – and said both are emphatic that the most inclusive language is using gender identity and expression. Furthermore, Mr. Wilson stated that both people working at these centers had been working with NEOLA and thought NEOLA had that as the proper language, adding that he hopes the district's policy uses identity and expression rather than what was proposed by NEOLA.

Mr. Schare said that as a member of the Franklin County Republican Party Central Committee, he had the honor of screening 24 legislative candidates across the county and has been asked by a few of the endorsed candidates for assistance with their education platforms, adding one candidate who will not need assistance is the Republican endorsed candidate Stu Harris from the 21st House District which represents about two-thirds of our district. Mr. Schare said that Stu Harris has been a Dublin School board member for the past 12 years and encouraged colleagues to get to know Mr. Harris as well as his Democratic opponents. In addition, Mr. Schare also encouraged colleagues to get to know Representative Andy Brenner who was endorsed as the GOP candidate for the 19th Senate District which includes 10,000 Worthington School district residents, adding that Mr. Brenner is the current chair of the Ohio House Education Committee and will probably be representing Worthington come 2019.

Mr. Schare also spoke about HB176, which is the anti-common core bill which has 27 cosponsors, explaining that HB176 would require the State Board of Education to establish Academic Content Standards consistent with what was in effect in Massachusetts in 2010. Next, Mr. Schare stated that HB200, which creates the Opportunity Scholarship program and has 8 sponsors, is different from current programs in that it is funded via direct state appropriations, adding that about 75% of kids statewide would fall in the income guidelines necessary to qualify for such a program with the amount of the scholarship depending on income. Next, Mr. Schare said HB102, which has been the discussion among legislative candidates, completely eliminates the dependence on property tax to fund public education in Ohio by replacing the local school property tax with a statewide property tax as well as a sharp increase in the state sales tax.

Finally, Mr. Schare spoke about SB216, the public school deregulation bill, which restores local control in such areas as teacher licensing, gifted services, and allow us to use paper for state assessments and help taxpayers with College Credit Plus costs by requiring students to pay half the cost of textbooks. Mr. Schare said the SB216 would also allow the student-teacher ratio for preschool to increase and requires the ODE to establish, distribute and monitor a mandate report for school districts while requiring school districts to provide a written report to its board if a mandate wasn't completed.

Mrs. Best said she received a beautifully written thank you card from TWHS Field Hockey Coach Terri Simonetti-Frost for honoring the team, adding that the board loves honoring its students and coaches.

Mrs. Best then began speaking about outgoing board member Mr. Schare and his service on the board of education and to the community. Mrs. Best explained that she met Mr. Schare 16 years ago and explained that while Mr. Schare and her were on opposites sides of a levy and levy repeal, from day one, their opinion on public education, funding, and finances was the same almost every time. Mrs. Best added that Mr. Schare has been an advocate for public education, and even though Mr. Schare had a lot of questions when he first came on the board, one of the things Mrs. Best really appreciated was Mr. Schare's understanding of school finances. Mrs. Best explained that school funding can be so confusing and Mr. Schare's understanding and insights have always been invaluable. Finally, Mrs. Best told Mr. Schare that she appreciates Marc's commitment and communication with our legislators and that his work on board policy was invaluable, stating she appreciated their time together, knows that Mr. Schare always had the best interest of the district, and that he will be greatly missed.

Mr. Shim thanked Mr. Schare for all his help with board policy work and that they worked very well together to be part of a team. Mr. Shim wished Mr. Schare the best and said it has been and honor and thanked Marc for everything he has done for the district.

Mr. Wilson explained that he first met Mr. Schare after a task force report and said that the questions Mr. Schare asked about that report were insightful and impressive, adding that he can remember being impressed by Marc and remain impressed to this day. Mr. Wilson stated that Mr. Schare and he disagree all the time on virtually everything, but he always enjoys talking to Marc because he is a straight-shooter and well-informed.

Mrs. Keegan said that she considers this evening a night of loss as she thinks the community is going to lose a dedicated, engaged, and enthusiastic board member. Mrs. Keegan said she also thinks the community is losing an eagle-eyed monitor of all financial information with the district, possibly the hardest working board member in the history of the district, and an advocate for more options for students. Mrs. Keegan then told Mr. Schare that she personally feels that she is losing a friend on the board and that the district is losing a person of great integrity.

Mr. Schare thanked all board members for their kind comments and thanked everyone for their support.
