Secondary factors to be taken into consideration

- Student and Staff Absenteeism
- Effects of asymptomatic quarantine students/staff on district operations
- Percentage of PCR tests that are positive during the last 14 days
- State of Ohio County Warning levels (Yellow, Orange, Red and Purple) for Franklin and Delaware
- School clinic visits/1000 for COVID/Influenza-like symptoms (relative to historical trends)
- District level Student Achievement Data (high school, middle schools, elementary school
- Central OH data on rates of infection and positive testing for specific age groups
- Other specific building data may indicate the need for step down at a particular building (example, an outbreak in a specific building)
- Teacher, staff, administration, parent data/feedback
- Expert opinions of county or state level public health officials

The purpose of secondary factor analysis will be to assist and further guide decision making at each two-week interval.

Vaccination Update

- Columbus Public Health is working with Worthington Schools to vaccinate our employees.
- Worthington staff has received both rounds of vaccinations and has been able to continue with normal school operations throughout the vaccination process.
- Columbus Public Health continues to be a GREAT partner!

Guidelines Effective March 22

- All safety protocols will remain in place.
- We will work to maintain a minimum of 3 feet of social distancing in classroom settings and 6 feet during lunch times. (<u>Ohio Schools COVID-19 Evaluation</u> from January 29, 2021 supports 3 feet of distancing with masks in classrooms and on school buses.)
- Face masks must continue to be worn at all times. Double masking is recommended but not required, health officials have advised that wearing a mask with at least two layers of fabric is recommended. Masks should include multiple layers of fabric, especially gaiters. Face coverings should be cloth/fabric and cannot be made of mesh or cloth/fabric that is transparent (with the exception of plastic components of a cloth/fabric face coverings that allow for viewing a person's mouth and face shields). Disposable masks are also allowable. Face coverings must cover an individual's nose, mouth, and chin. Worthington Schools will have masks on hand and will happily provide one for any student who needs one.

- Practicing regular good hygiene-washing hands, hand sanitizer will continue.
- Quarantine guidelines remain unchanged (even if vaccination has occurred.)

Ohio Department of Health Quarantine

- Identify close contacts
- Confirm face coverings and safety protocols were in place
- If a student is found to be within 3 feet of a person who tested positive with COVID-19 for more than 15 minutes, the students must quarantine from school and all other activities. If a student is found to be between 3 feet and 6 feet of a person who tested positive with COVID-19 for more than 15 minutes while wearing masks, the student may attend school but must be quarantined for 10 days from after-school activities, including sports. Finally, if a student is found to be more than 6 feet of a person who tested positive with COVID-19, the student does not need to be quarantined.
